Award categories	Objective
Pharma Company of the Year	Audited parameters such as sales, exports, R&D expenditures, duly certified by Company Secretary, to be considered. Also list of Protocol and Non-protocol drugs (as per CDMC monitoring) proposed to be considered – if required, CDSCO's comments will be taken.
Excellence in Research & Development	To recognize an organisation for their valiant efforts to conduct extensive research in the field of pharma to improve their existing products or to create a new product / technology.
Pharma Start-up of the Year	Recognizing the outstanding achievements and tremendous growth which has positively impacted the industry. The annual revenue of the company for the FY 2023-24 to not be more than INR 100 Crores.
Excellence in Contribution Towards Sustainability	To recognise a pharma company which made sustainability an integral part of their business practices. This can include initiatives related to waste reduction, energy saving solutions, sustainable and collaborative product development, initiatives to minimize environmental impact etc.
Excellence in Packaging & Innovation	To recognize the initiatives with respect to any new technology and how the product is different with respect to packaging as a medium for self-expression and differentiation and patient convenience.
Excellence in Supply Chain Logistics & Good Distribution Practices	To recognize the supply chain and logistics initiatives or processes undertaken within the urban or metro regions for ensuring safe handling and timely tracking of drug substances, raw materials, finished drug products, etc.
Excellence in Pharma Exports	Though the global share of Indian pharmaceutical products has increased over time, there is further potential for increasing the share by targeting products with high potential and boosting domestic manufacturing of identified products. Government of India approved the Production Linked Incentive (PLI) Scheme, PLI Scheme for Bulk Drugs and Common Infrastructure Facilities (CIF) in bulk drug parks.
Excellence in CSR	Recognize the CSR initiatives undertaken by the organizations with intent for social cause/awareness towards the betterment of the society, environment, people, etc.
