About Conference

With introduction of new criminal laws, effective from July 1, 2024, India's landmark move has replaced the three laws of colonial era i.e. IPC of 1860, the CrPC of 1973 and the Indian Evidence Act of 1872. The modernised legal frameworks aim at bringing a paradigm shift in the justice delivery system. A business, being an artificial person created under law, deals with multiple natural persons and include third-parties, machines, and tools & technologies such as advanced generative, predictive and disruptive artificial intelligence (AI). Thus, it is contextually imperative that businesses would need to interface with and comply to the new criminal laws.

A large number of corporate laws have been decriminalised by the Government of India, nevertheless, it is in respect of the rights and duties as well as obligations of businesses which may accrue to them in the event of- with or without wilful act or negligence or omission of person or persons associated with organisations. Since the corporate crimes of civil nature would remain encircled within the ambit of respective new laws, this underscores the need of corporate promoters, directors and KMPs to stay tuned up about nuanced understanding of new criminal laws.

In view of the above, and to equip the industry stakeholders with the requisite knowledge, ASSOCHAM in association with AQUILAW is organising a national conference on the captioned subject.
