## Background

In current scenario, the pressing demand is more on part of regulations pertaining to ESG frameworks, AI-based infrastructure, human resource interface, labour laws, data privacy and protection alongside protection of trade-secrets and ensuring that there are no economic espionages to the organisation.

Towards meeting the yearly budgets, the contribution to the economic agenda of the organizations and country as a whole is a primary concern and amid all the most legal complexities, the expectations remain centred around General Counsel being the key functionary. The impact of increasing regulatory oversight, stricter competition enforcement, new compliance requirements and rapidly changing global regulations are making it harder for GCs to fulfill their core risk management function.
