Ind-Ra sees inflation easing to 4.7 per cent in FY25

India Ratings and Research (Ind-Ra) expects inflation to ease to 4.7 per cent in 2024-25, allowing the Reserve Bank of India (RBI) to cut interest rates by 25 basis points (bps) in April 2025 to support growth.

GAIL to receive 12 LNG cargoes annually under five-year deal with Qatar Energy

GAIL will begin receiving 12 LNG cargoes annually under a five-year agreement with Qatar Energy Trading starting in April 2025, according to Sandeep Kumar Gupta, chairman and managing director, GAIL. Additionally, GAIL has signed long-term LNG procurement agreements with Vitol Asia for approximately 1 million tonnes a year over 10 years.

RBI's new loan sales rule to boost banks' profit by INR20k crore

Banks and non-bank lenders are set to gain up to INR20k crore in the March 2025 quarter after the RBI eased rules allowing immediate booking of recoveries on assets sold to the state-backed National Asset Reconstruction Company. The revised guidelines permit lenders to reverse excess provisions in their profit and loss accounts if loans are transferred to an asset reconstruction company (ARC) at a value exceeding their net book value.
