FY25 capex may exceed INR10.2 trillion target

The central government expects to exceed the revised capital expenditure (capex) estimate of INR10.2 trillion for 2024-25, based on advance data, senior government officials informed Business Standard. However, data from the Controller General of Accounts for April-February 2025 shows a shortfall of more than INR2 trillion.

Aramco slashes oil prices as OPEC+ announces output hike

Saudi Aramco has slashed its flagship Arab Light crude prices to Asia by USD 2.3 per barrel for May 2025 deliveries, marking the steepest cut in more than two years, according to Bloomberg. The move come just after the OPEC+ alliance has announced an output hike of over 400,000 barrels per day, expected to commence in May 2025.

GAIL likely to get up to 35 per cent increase in integrated tariff

GAIL (India) is expected to receive a 35 per cent increase in pipeline tariffs, potentially boosting its pre-tax earnings by INR34 billion annually, according to its chairman Sandeep Kumar Gupta. The proposed integrated pipeline tariff stands at INR78 per metric million British thermal units (mmBtu), up from the current INR58.6 per mmBtu.

NBFCs' loan growth projected at 15 per cent in March 2025 quarter
