CHALLENGE (10% weightage)

- Describe the situation and the specific business/consumer challenge addressed.
- Share key statistics providing insights into the scale and intricacies of the identified challenge.

SOLUTION (35% weightage)

- Explain the rationale behind choosing your solution for the identified problem.
- Highlight the core insight guiding your strategic thinking and outline the distinctive, impactful tools and methods applied.
- Special credit will be given for solutions that foster innovation, uniqueness and sustainability efforts.

DELIVERY (30% weightage)

- Provide an overview of the implementation of your strategy.
- Detail the various tactics and elements used, clarifying their role in achieving the business objective.

PERFORMANCE (25% weightage)

- Present clear evidence and metrics demonstrating the success of the strategies.
- Explain with Financial, Sales and Customer KPIs and other indicators, if any, justifying the nominee's qualification for the Award
